



All other participants are considered self-sponsored and must shoulder their respective expenses for accommodation, air ticket, and allowances, among others.












Venue

Visa Requirements

Participants are **REQUIRED** to obtain an appropriate entry visa from the Embassy of the Republic of the Philippines or the Philippine Consulate General Royal Thai Consulate-General before entering the Philippines, **EXCEPT** for those listed as Visa-Free. Please see attached matrix of visa policy for the delegates who will attend the event (**ANNEX A**).

To apply for an appropriate Entry Visa to the Philippines, participants should contact their nearest Philippine Embassy, Consulate-General or Foreign Service Post for the most updated information regarding visa application procedures and required documents. Please see attached files for reference:

Entry Requirements

With regards to "Public Health Measures for Foreign Travellers Entering the Philippines", effective from 22 July 2022 until further notice, please be informed of the following:

Proof of COVID-19 vaccination is NO LONGER REQUIRED Proof of health insurance is NOT REQUIRED at the Manila International Airport Authority

Any passenger intercepted as having symptoms of COVID-19 on arrival shall undergo secondary assessment by the Quarantine Medical Officer and may be directed to a hospital as per discretion of delegates embassy

Air Tickets (for Sponsored Participants)

UNDRR will provide air tickets and financial support to sponsored participants, in accordance with United Nations travel rules and regulations. This includes round trip air tickets based on the most economical route available.

UNDRR will directly contact sponsored participants for ticket arrangements. Air tickets will be issued by UNDRR's authorized Travel Agent (AMEX). It is recommended that participants arrive in Manila on Sunday, 13 October 2024 and depart on Saturday, 19 October 2024.

Sponsored participants **ARE NOT** authorized to purchase their own tickets without approval from UNDRR. **Reimbursement of air tickets bought by sponsored participants without approval is not permissible under UN rules.**

After the ticket is issued, participants should contact AMEX themselves for **ANY CHANGES OR TICKET UPGRADES**. Any additional cost for such changes in itinerary or air travel will be borne by participants.

Travel insurance is not included in the sponsorship; therefore, it is strongly recommended that each participant purchase their own insurance prior to departure.









Daily Subsistence Allowance (for Sponsored Participants)

UNDRR will pay Daily Subsistence Allowance (DSA) and terminals expenses to the sponsored participants according to the UN rules and regulations. DSA covers meals and miscellaneous expenses (i.e., visa fee, in-country transportation, travel insurance, etc.) during the period of the meeting. Any additional expenses (e.g., room service, laundry, telephone, mini bar, urban transportation, etc.) are at personal expense of the participant.

Participants who wish to stay beyond the official mission dates have to bear any additional costs related to travel and accommodation.

Airport terminal expenses, which amount to 63 USD per transfer ($63 \times 4 = 252$ USD) are also included. Terminal expenses are intended to cover transportation from the residence to the airport, to the hotel, and vice versa.

DSA could be paid either by wire transfer (for those whose bank account registered in the UN database) or in cash. Sponsored Participants will be informed of the payment method when travel arrangements are made.

(Note: please refer to mention of self-ticket process above. Reimbursement of air tickets bought by sponsored participants without prior approval is not permissible under UN rules)

Upon submitting the complete documents listed above, each participant is required to sign the payment roster. The location of the DSA payment office will be confirmed later.

Local and long-distance telephone calls, Internet usage, business center usage, laundry, room and hotel transportation services, mini-bar items, as well as restaurant and bar services are **NOT INCLUDED** in this coverage and should be settled by the participant before departure.

Accommodation (for Self-sponsored Participants)

Hotels, located relatively close to the PICC or more readily accessible by mass-transit routes, have been identified for use by participants. The list of recommended hotels with addresses, classification, proximity to PICC and other related information, is available (**ANNEX D**).

Self-sponsored participants should make reservations directly with the recommended hotels based on the list in Annex D. Cancellations, postponements or other changes should be reported immediately to the hotel. Rooms not occupied may be charged to the participants in accordance with hotel policies.

Before departure, participants should settle directly with the respective hotels all accounts, including room charges and other expenses including local and long-distance telephone calls, Internet usage, business center usage, laundry, room and hotel transportation services, minibar items, as well as restaurant and bar services. Participants are also accountable for any charges incurred with respect to rooms remaining vacant owing to late arrival or rescheduled departure for which inadequate prior notice is given.

Transportation (for Sponsored Participants)

The Government of the Philippines will provide transportation to ministers and their accompanying persons from and to Airport, to and from PICC, and **to and from Conrad Manila.**

The most recommended ride-hailing application is Grab.













Using the Grab application:




1 Select "Car"

Badges

Photo badges will be used at PICC for access to the various meeting and events venues.

Photo badges will be available for pickup at PICC starting 13 October between 08:00 AM and 10:00 PM.

For proper identification and security reasons, all participants are **REQUIRED** to wear their badges at all times while they are in the Conference Center.

Loss of a badge should be immediately communicated to the Registration Counter or the liaison officers, so that the incident may be recorded, and a new badge may be issued.


Weather


According to the Philippine Atmospheric Geophysical and Astronomical Services Administration (PAGASA), as of 07 March 2024, La Niña Watch has been raised. Model forecasts suggest an increasing probability of La Niña to develop in the June-July-August.

Power plugs and sockets

In the Philippines, power plugs and sockets (outlets) of type A and type B are used. All power sockets in Philippines provide a standard voltage of 220V with a standard frequency of 60Hz. You may need to prepare a power plug (travel) adapter.

 - b. Official designation
 - c. Expected departure from country of origin
 - d. Expected duration of assignment or temporary visit to the Philippines
 - e. Complete name and designation of the official in Mission being replaced, if applicable
 - f. Purpose of Travel
 - g. In the case of qualified dependents, that the visa applicant is traveling to the Philippines to join and live with the principal for the duration of the principal's assignment
- 2. Duly filled out application form (with photograph)
- 3. Clear photocopy of the visa applicant's passport
- 4. Copy of the previously issued 9(e) visa, if applicable
- 5. Supporting documents to establish family ties, marital union, employee-employer relations, etc., as may be deemed necessary in order to properly ascertain appropriate visa type per existing rules and regulations

Requirement for Issuance of 9(a) Temporary Visitor's Visa

- 1. Duly accomplished visa application form (FA Form No. 2) with a passport-size photograph taken during the last six (6) months
- 2. Passport valid for at least six (6) months beyond authorized period of stay in the Philippines
- 3. Tickets or flight reservation (entry and exit)
- 4. For business purposes, Letter from employer or sponsor (which may be the inviting party in the Philippines) indicating the specific purpose of travel, length of stay (inclusive dates), and company guarantee for all moral and financial obligations to be incurred by the applicant while in the Philippines
- 5. Proof of income
 - Bank statement of the latest six (6) months or tax payments
- 6. Hotel accommodation or proof of lodging
